Finance Function – Prior Year Accomplishments: 2011-2012

Overall Financials

- Assets were down a total of 3.4% from last June
- Income were within 5% of overall budget at year end
- Expenses were within 5% of overall budget at year end
- Reserves held at same level as last June with slight increase from interest earned (non-Operating funds)
- On a monthly basis our Financials were reconciled and presented to the Board for review / comment
- FY2011 taxes successfully completed and filed with IRS in a timely fashion

Accomplishments

- Improved expense reimbursement / check request process and payment cycle improvements
- Upgraded to QuickBooks Online software for greater Board visibility to Financials and new features available for reporting, reconciliations, etc
